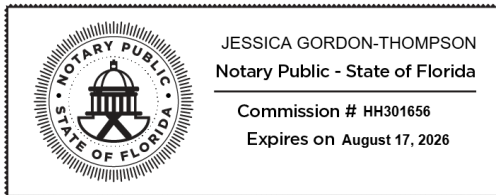

CITY OF RACINE 2025 CAPER NOTICE OF PUBLIC COMMENT PERIOD

The City of Racine will submit its 2025 Consolidated Annual Performance and Evaluation Report (CAPER) to the U.S. Department of Housing and Urban Development (HUD) on or before March 31, 2026, following consideration of comments received during the public comment period. The CAPER describes the use of Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), and Emergency Solutions Grant (ESG) funds during the City's 2025 program year.

The 15-day public comment period will begin March 10, 2026 and end March 25, 2026. Written comments must be received no later than 4:30 p.m. Central Time on March 25, 2026, in accordance with HUD citizen participation requirements.

The draft CAPER will be available for public review beginning March 9, 2026, on the City's website at <https://cityofracinewi.gov/citydevelopment/planning-division/cityplans/> and at Racine City Hall, Room 304, 730 Washington Avenue, Racine, Wisconsin, Monday through Friday between 8:00 a.m. and 4:30 p.m. A reasonable number of free copies will be made available upon request.

Written comments may be submitted by email to Neighborhood.Services@cityofracine.org or by mail or hand delivery to Department of City Development, Attn: CAPER Comments, 730 Washington Avenue, Racine, WI 53403. All comments received during the comment period will be considered, and a summary of comments and responses will be included in the final CAPER submitted to HUD.

The City of Racine will make reasonable accommodations for persons with disabilities.
