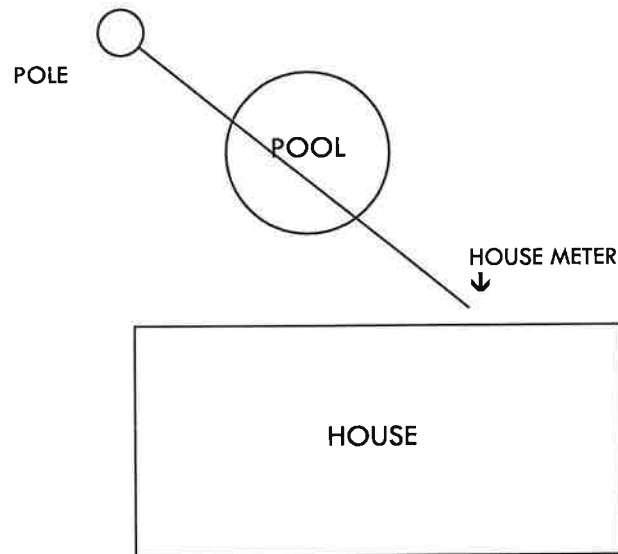

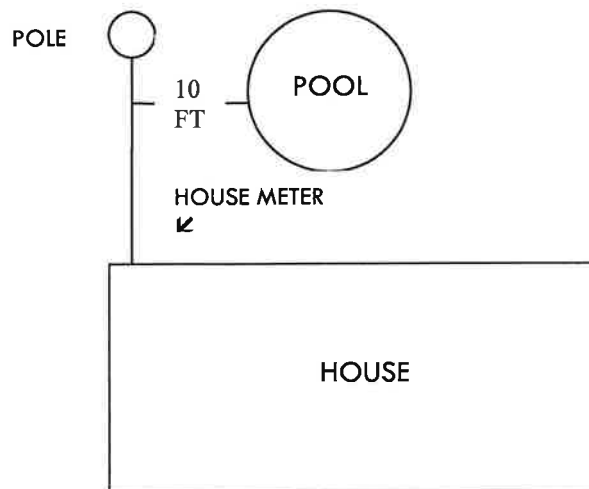

Swimming Pool Information

Section 18-746 through Section 18-753

DEFINITIONS

SWIMMING POOL Any body of water 12 inches deep or more, in an artificial/semi-artificial receptacle or container, above or below ground, intended for swimming or wading.

POOL COVER Safety cover, which can support at least 200 pounds of weight, attached to pool or ground.

UNATTENDED POOL A pool without a person at least 12 years old in charge.

AUTHORITY TO CONTROL POOLS

Private – Building Inspector Public – Health Officer and/or appointed agent

BUILDING PERMITS REQUIRED

For pool intended to remain filled for a period longer than 48 hours.

For existing pools being enlarged.

FEE: \$100.00 PER POOL

POOL LOCATIONS ON LOTS

Minimum (May apply for a variance)

- 60 feet from front lot line
 - 2 feet from side and rear lot lines
 - 8 feet from adjoining buildings
 - 2 feet from fences
- (exceptions made for corner lots)

FENCES

4 feet high with no openings greater than 4 inches; buildings and shrubs can be used as part of the fence. All gates must be self-closing with self-latching gates.

UNATTENDED POOLS

Less than 42 inches from the ground to the top of pool edge **MUST BE** drained, covered or fenced in. The surrounding area must be clear of items which may permit entry into the pool. **LADDERS** must be removed or in the safety position.

COMPLAINTS

Inspected by a Building Inspector. If a violation exists, the pool owner will be given 5 days to comply. The pool owner has a right to appeal inspections.

CAUTIONARY STATEMENT TO OWNERS OBTAINING BUILDING PERMITS

Section 101.65 (lr) of the Wisconsin Statutes requires municipalities that enforce the Uniform Dwelling Code to provide an owner who applies for a building permit with a statement advising the owner that:

If the owner hires a contractor to perform work under the building permit and the contractor is not bonded or insured as required under Section 101.654 (2) (a) the following consequences might occur:

a) The owner may be held liable for any bodily injury to or death of others for any damage to the property of others that arises out of the work performed under the building permit of that is caused by any negligence of the contractor that occurs in connection with the work performed under the building permit.

b) The owner may not be able to collect from the contractor damages for any loss sustained by the owner because of a violation by the contractor of the one and two family dwelling code or an ordinance enacted under Sub (1) (a) because of any bodily injury to or death of others or damage to the property of others that arises out of the work performed under the building permit or because of any bodily injury to or death of others or damage to the property of others that is caused by any negligence by the contractor that occurs in connection with the work performed under the building permit.

Cautionary Statement to Contractors for Projects Involving Building Built Before 1978

If this project is in a dwelling or a child-occupied facility, built before 1978, and disturbs 6 sq. ft. or more of paint per room, 20 sq. ft. or more of exterior paint, or involves windows, then the requirements of ch. DHS 163 requiring Lead-Safe Renovation Training and Certification apply. Call (608)261-6876 or go to the Wisconsin Department of Health Services' Lead homepage for details of how to be in compliance.

Wetlands Notice to Permit Applicants

You are responsible for complying with state and federal laws concerning the construction near or on wetlands, lakes and streams. Wetlands that are not associated with open water can be difficult to identify. Failure to comply may result in removal or modification of construction that violates the law or other penalties or costs. Additional Responsibilities for Owners of Projects Disturbing One or More Acre of Soil

I understand that this project is subject to ch. NR 151 regarding additional erosion control storm water management and will comply with those standards.

Contractor Credential Requirements

All contractors shall possess an appropriate contractor credential issued by the Wisconsin Division of Industry Services. Contractors are also required to only subcontract with contractors that hold the appropriate contractor credentials.
