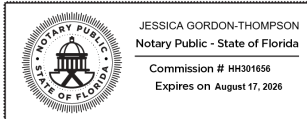

**2025-2029 CON PLAN & 2025 AAP NOTICE
PUBLIC NOTICE OF COMMENT PERIOD AND PUBLIC HEARING
ON FY 2025-2029 CONSOLIDATED PLAN AND FY 2025 ANNUAL ACTION PLAN**

On or about Monday, July 14, 2025, the City of Racine, Wisconsin will file with the Wisconsin State Office of the U.S. Department of Housing and Urban Development (HUD) the City's 2025-2029 Consolidated Housing and Community Development Plan (Con Plan) and 2025 Annual Action Plan (AAP). The AAP describes the City's proposed use for fiscal year (FY) 2025 available Federal and other resources to address the priority needs and specific objectives in the Con Plan; the City's method for distributing funds to City departments and not-for-profit organizations; and the geographic areas of the City to which it will direct assistance.

All interested parties are encouraged to review the draft plans and invited to comment by either sending an email to nsdapplications@cityofracine.org or sending a letter to 730 Washington Avenue, Attn: Veronica Seymour, Racine, WI 53403. This public comment period will begin on Wednesday, June 4, 2025, and extend through 5pm on July 3, 2025. All comments must be received by 5pm on Thursday, July 3, 2025. Interested parties may also provide comments on the draft plans at the public hearing that begins at 3:00pm on June 16, 2025. The meeting will be held in Room 303 of City Hall, 730 Washington Ave. Racine, WI 53403.

The Con Plan describes the use of funds stemming from the Community Development Block Grant (CDBG) program, the HOME Investment Partnerships (HOME) program, and Emergency Solutions Grant (ESG) program. The 2025 CDBG allocation is \$1,743,518. The 2025 HOME allocation is \$479,767.40. The 2025 ESG allocation is \$155,704. All annual allocations are expected to be similar during the 2025-2029 timeframe.
